Guidelines for applying for Online Fire NOC

- A. Who can apply: Every individual or Authorized person.
- B. How can apply: The application can be submitted through the following steps-
 - Step-1 Visit:- www.edistrict.tripura.gov.in
 - Step-2 Citizen Registration: Create Login ID & Password (Register yourself either by clicking "Citizen Registration" under "Citizen Section" or "Register Yourself" button on Login popup)
 - Step-3 Login (Login with your login credential)
 - Step-4 Apply for Service
 - Step-5 View all services
 - Step-6 Select service you wish to apply for:
 - 1. Fire Safety Certificate based on Self Certification
 - 2. (Step-I) Fire Safety Recommendation (Step-II) Fire Safety Certificate NOC
 - 3. i) Renewal of Fire Safety Certificate based on Self Certification ii) Renewal of Fire Safety Certificate
 - Step-7 Fill-up the online form and submit.
 - Step-8 Attach Annexure (upload scanned supporting documents in PDF and submit)
 - Step-9 E-Sign through Aadhaar
 - Step-10 Make Payment through e-Grass leading to automatic application submission (select payment mode and continue)
 - Step-11 Print the acknowledgement.
- C. Application Fee: i) One time application fee ₹ 3,000/- (Rupees three thousand) only.
 ii) Renewal fee ₹ 2,500/- (Rupees two thousand five hundred) only.
- D. Validity of Fire Safety Certificate:
 - i) 05 (five) years for residential buildings from the date of issue.
 - ii) 03 (three) years for non-residential buildings or premises from the date of issue.
- E. Available services under HOME (Fire and Emergency Services) Department :
 - 1. Fire Safety Certificate based on Self Certification
 - 2. Fire Safety Recommendation
 - 3. Fire Safety Certificate NOC
 - 4. Renewal of Fire Safety Certificate based on Self Certification
 - 5. Renewal of Fire Safety Certificate NOC

G. Cancellation of Fire Safety certificate

- Any Self Certificate, if found false or otherwise, will be treated as willful criminal negligence and shall be brought to justice under appropriate provision of prevailing law of the land.
- 2. Owner or occupier shall maintain the fire prevention & life safety measures in operational condition at all times, in the manner and specifications as prescribed by rules. Failing that, the Fire Safety Certificate shall be cancelled and legal action shall be taken against the owner or occupier.

H. Conditions for Fire Safety Certificate based on Self Certification

Any Self Certificate, if found false or otherwise, will be treated as willful criminal negligence and shall be brought to justice under appropriate provision of prevailing law of the land.

- i) Residential: Height of the building up to 15 mtrs. or covered area up to 1000 sqm.
 - ii) Non-Residential: Height of the building up to 08 mtrs. and covered area up to 100 sqm.

- 1. Power of Attorney (if applicable)
- 2. Self Certification in prescribed format (Affidavit before First Class Judicial Magistrate or at least Notarized)
- 3. <u>For existing building</u>: Approved Building Plan (comprises Site Plan, Elevation, Floor Plans, Terrace Plan) including Commercial or Residential permission. OR

<u>For proposed building</u>: Drawings of Building Plan (comprises Site Plan, Elevation, Floor Plans, Terrace Plan) by mentioning the occupancy details.
