Bids shall not be considered in case the EMD is not submitted along with the Technical bid.
4. The sealed cover shall be superscripted by the expression **“ Tender for Re-filling of empty Co<sub>2</sub> Fire Extinguisher with Hydro Test having capacity of 2 KG capacity for Directorate of Tripura Fire & Emergency Services, due on 17.03.2025.**
